- DATE:** Sunday - February 7, 2010
- SESSIONS/TIMES:** **SESSION I: children whose weights are 30lbs – 59lbs; report at 7:30am; wrestling starts at 8:30am**
SESSION II: children whose weights are 60lbs – 150lbs; report at 11am; wrestling starts at 12noon
- LOCATION:** Frelinghuysen Middle School, West Hanover Ave., Morristown, New Jersey 07960
- WEIGH-INS:** There will be no weigh-ins. This tournament is on the honor system with a scale at the head table for challenges. Each head coach will certify the weights of their wrestlers approx. (2) weeks prior to the tournament.
- AGE/WEIGHT:** Kindergarten through 5th grade only. Wrestlers will be divided up by age and ability where possible. We will create weight classes based on the kids that have registered.
- RULES:** Scholastic Rules; CADETS and CARDED OFFICIALS; NO SEEDING (Separation by Town); Periods: 1, 1, 1 and overtime, if necessary. This is a double elimination tournament. All wrestlers will wrestle (2) matches. **Head gear required**
- ELIGIBLE:** 1st and 2nd year wrestlers only. Any exceptions must be approved by Tournament Director.
- AWARDS:** All competitors will receive a medal, and a special medal for 1st, 2nd, and 3rd.

Follow directions from Ridgedale Ave below. **From Ridgedale Ave:** At third (3rd) traffic light turn left onto Hanover Avenue (Agway on left). At the fifth (5th) traffic light turn left (ball field on left) School is at the end of the driveway. **From Route 24 West:** Exit 1A (Morristown/ Whippany Road) Stay in Ramp lane and make immediate right onto Hanover Avenue. At sixth traffic light turn left (ball field on left) School is at end of driveway.
